Finally, the materials are done from a perspective (a common historical perspective) that sees Torts as being about promoting a transcendent form of justice. Louis Hensler has taught Torts at Regent University School of Law since he joined the faculty in 1998. Before that, Professor Hensler graduated from the University of Chicago Law School in 1988, clerked for the Honorable J.L. Edmondson on the United States Court of Appeals for the Eleventh Circuit, and then practiced as a litigation associate with the Pittsburgh office of Jones Day.
